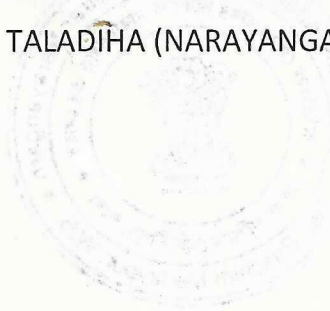

NOW THIS DEED WITNESSETH AS FOLLOWS:

**1. NAME OF THE TRUST**

## 2. REGISTERED OFFICE

The registered office of the Trust shall be situated at:

Village – Taladiha

Post – Birbira

P.S. – Narayangarh

District – Paschim Medinipur

State – West Bengal

PIN – 721437

The above premises has been taken on rent from Mr. Saktipada Pal S/o. Bhupati Charan Pal who is the lawful owner of the property. The Trust is using a room in the said premises as its office and is paying monthly rent to the owner.

The owner of the property has given his No Objection Certificate (NOC) permitting the Trust to use the said premises as the registered office of the Trust.

## 3. OBJECTIVES OF THE TRUST

The main objectives of the Trust are as follows:

1. To promote and support education among poor, needy and underprivileged students in society.
2. To provide books, study materials, school supplies, uniforms and other educational assistance to deserving students.
3. To establish, run and support schools, coaching centres, libraries, training institutes and other educational institutions.
4. To organize educational programs, seminars, workshops, awareness campaigns and training camps for the development of students and youth.
5. To promote digital education and provide computer education and skill development programs.
6. To provide scholarships, financial assistance and educational support to students belonging to economically weaker sections.

7. To promote vocational education and skill development programs to help youth become self-reliant.
8. To encourage research, innovation and educational development activities in the field of education.
9. To collaborate with government bodies, educational institutions and social organizations for the promotion of education.
10. To undertake all such lawful activities that are beneficial for the advancement of education and social welfare.
11. To carry on income-generating activities, including educational, training, skill development, publication, consultancy, and other lawful activities, provided that all such income shall be used solely for the objectives of the Trust and not for any personal profit.

#### 4. TRUST FUND

The Settlor has contributed a sum of ₹ 1000 (Rupees **One Thousand** only) as the initial Trust Fund for the establishment and functioning of the Trust.

The Trust may receive funds from the following sources:

1. Donations from individuals or institutions
2. Grants from Government or private organizations
3. Membership fees
4. Income generated from educational or social activities of the Trust
5. Any other lawful source

All income, funds and property of the Trust shall be utilized solely for the objectives of the Trust and no Trustee or member shall derive any personal benefit from the Trust.

The funds of the Trust shall be kept in a bank account opened in the name of the Trust and shall be operated in accordance with the decision of the Board of Trustees.

Proper accounts of all income and expenditure of the Trust shall be maintained and financial records shall be prepared as required.

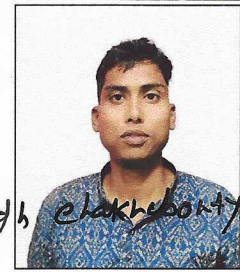

## 6. POWERS OF TRUSTEES

The Board of Trustees shall have the following powers for the management and functioning of the Trust:

1. To manage, control and supervise all the activities and affairs of the Trust.
2. To open and operate bank accounts in the name of the Trust and to carry out financial transactions as required.
3. To receive donations, grants, contributions or financial assistance from individuals, institutions or government bodies for the objectives of the Trust.
4. To acquire, purchase, lease, rent or otherwise use land, buildings or other property for the activities of the Trust.
5. To appoint teachers, employees, staff members or volunteers for carrying out the educational and social activities of the Trust.
6. To frame rules, regulations and administrative policies for the proper functioning of the Trust.
7. To establish, run and manage schools, libraries, training centres and other educational institutions in accordance with the objectives of the Trust.
8. To appoint members or volunteers to assist in the activities of the Trust.
9. To appoint new Trustees or remove any Trustee if required in the interest of the Trust.
10. To take all lawful decisions and undertake necessary activities for achieving the objectives of the Trust.
11. To develop and maintain websites, digital platforms and online resources for promoting educational and social welfare activities of the Trust.

## 7. DUTIES OF TRUSTEES

The Trustees shall have the following duties for the proper administration and functioning of the Trust:

1. To carry out the activities of the Trust in accordance with the objectives and policies of the Trust.
2. To manage the funds, property and assets of the Trust honestly, responsibly and transparently.

3. To maintain proper accounts of all income and expenditure of the Trust and prepare financial statements whenever required.
4. To operate the bank accounts of the Trust and ensure that financial transactions are carried out as per the decisions of the Board of Trustees.
5. To convene meetings of the Trustees whenever necessary and implement the decisions taken in such meetings.
6. To safeguard the reputation, interests and integrity of the Trust and work sincerely towards achieving its objectives.
7. To maintain and preserve all records, documents and accounts of the Trust properly.
8. To plan and implement educational and social welfare activities of the Trust effectively.
9. To supervise members, employees or volunteers engaged in the activities of the Trust.
10. To undertake all lawful actions necessary for achieving the objectives of the Trust.

### 8. INDEMNITY

- 1) The Trustees shall be indemnified and kept indemnified out of the funds of the Trust against all losses, claims, damages, costs and expenses which they may incur or become liable for in the proper discharge of their duties and functions, except in cases of willful negligence, fraud or misconduct.

### 9. BANK ACCOUNT

- 1) The Trust may open one or more bank accounts in the name of the Trust (**SHIKHAR ALO TRUST**) in any nationalized or scheduled bank for the purpose of managing the financial transactions of the Trust.
- 2) The bank account shall be operated as per the resolution of the Board of Trustees. Normally the account shall be jointly operated by any two among the Chairman, Secretary and Treasurer of the Trust.
- 3) All funds of the Trust shall be deposited in the Trust's bank account and shall be utilized only for the objectives of the Trust.
- 4) Proper records and accounts of all financial transactions shall be maintained under the supervision of the Board of Trustees.

### 10. MEETING OF TRUSTEES

- 1) The Board of Trustees shall meet from time to time for the proper management and functioning of the Trust. However, **at least three (3) meetings shall be held every year.**

- 3) The presence of at least half of the total number of Trustees shall constitute the quorum for the meeting.
- 4) All decisions shall be taken by the majority vote of the Trustees present in the meeting. In case of a tie, the Chairman shall have the casting vote.
- 5) All discussions and decisions taken in the meeting shall be recorded in writing and preserved as official records of the Trust.
- 6) In case of urgent matters, a special meeting may be called by the Chairman or the Secretary.

## 11. MEMBERSHIP

- 1) For the purpose of expanding and supporting the activities of the Trust, the Board of Trustees may appoint general members or volunteers as required.
- 2) Any person who wishes to become a member of the Trust may apply to the Board of Trustees, and membership shall be granted upon approval of the Board.
- 3) All members of the Trust shall abide by the objectives, rules and policies of the Trust and shall cooperate in the activities of the Trust.
- 4) If any member violates the rules of the Trust, damages the reputation of the Trust, or acts against the interest of the Trust, the Board of Trustees shall have the authority to cancel the membership of such person.
- 5) Any member may resign from membership by giving written notice to the Board of Trustees.
- 6) The names, addresses and other necessary details of all members shall be maintained in a Member Register of the Trust.

## 12. NO PROFIT CLAUSE

- 1) The Trust shall be a non-profit charitable organization.
- 2) No part of the income, funds or property of the Trust shall be paid or transferred directly or indirectly by way of profit, dividend or otherwise to any Trustee, member or any person related to them.
- 3) All the income, funds and assets of the Trust shall be used solely for the promotion and fulfilment of the objectives of the Trust.

## 13. GOVERNMENT COMPLIANCE

- 1) The Trust shall comply with all applicable laws, rules and regulations of the Government of India and the State Government.
- 2) The Trust shall obtain all necessary registrations, permissions, licenses and approvals required for carrying out its activities, including educational and social welfare programs.

- 1) The Trust shall apply for registration under relevant provisions of the Income Tax Act, including 12A and 80G, in order to avail tax benefits and to encourage donations.
- 2) All activities of the Trust shall be carried out in compliance with the conditions required for such registrations.

#### 16. VOLUNTEERS

- 1) The Trust may appoint volunteers for assisting in its activities and programs.
- 2) The roles, responsibilities and duties of such volunteers shall be defined by the Board of Trustees.
- 3) Volunteers shall work in accordance with the objectives and policies of the Trust.

#### 17. DIGITAL AND ONLINE ACTIVITIES

- 1) The Trust may undertake digital and online activities including running websites, online education platforms, digital training programs and other internet-based services for the promotion of its objectives.

#### 18. AMENDMENT

- 1) For the better administration of the Trust and to meet changing circumstances, the rules and provisions of this Trust Deed may be amended, modified or supplemented as required.
- 2) Any such amendment or modification shall be made only with the approval of the majority of the Trustees in a duly convened meeting of the Board of Trustees.

- 3) The Trustees shall manage and safeguard the Trust properties.

## 21. COMMON SEAL

- 1) The Trust may have a Common Seal, which shall be kept in the custody of the Secretary of the Trust.
- 2) The Common Seal shall be affixed to documents only with the approval of the Board of Trustees.

- 3) The remaining assets and funds shall be transferred to another charitable or educational trust, institution or organization having similar objectives, as decided by the Board of Trustees.
- 4) Under no circumstances shall the assets or funds of the Trust be used for personal benefit of any Trustee or member.
